All UG students whose total family income from all sources is less than Rs. 2.50 lakh are eligible to apply for this scholarship. Interested and eligible students are required to apply **ONLINE** through NSP Portal (<a href="https://scholarships.gov.in">https://scholarships.gov.in</a>). The students are requested to submit one set of copies of following documents in the scholarship section.

## **Eligibility Criteria:**

- 1. Annual family income from all sources up to Rs.2.50 lakh
- 2. Top 98 OBC, EBC, and DNT students (JEE Mains Rank)

## Documents required for renewal of scholarship:

- 1. Cast certificate issued by the competent authority
- 2. Income certificate issued by the competent authority (which was uploaded earlier)
- 3. Previous academic year Grade sheet (xerox copies)
- 4. Application form of NSP along with supporting documents mentioned above.

#### Documents required for fresh scholarship:

- 1. Bonafide certificate
- 2. Cast certificate issued by the competent authority (OBC-NCL, EBC, issued from 01-04-2025)
- 3. Income certificate issued by the competent authority (from 01.04.2025)
- 4. Bank pass book (xerox copy)
- 5. SSC/Equivalent Exam Certificate (xerox copies)
- 6. Intermediate/Equivalent Exam Certificates (xerox copies)
- 7. JEE mains rank card
- 8. Aadhar Card
- 9. Application form of NSP along with supporting documents mentioned above

Note: If the student applied for the National Level Scholarship Schemes, he has to choose to get benefit from only one source/scheme and return the other benefit, if sanctions are received from both the schemes. Otherwise, it cost the misuse of the government money and will be subjected to disciplinary actions.
