2. 4. Preference to Make In India products (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. 3. Generic

Manufacturer Authorization:Wherever Authorised Distributors/service providers are submitting the bid, Authorisation Form /Certificate with OEM/Original Service Provider details such as name, designation, address, e-mail Id and Phone No. required to be furnished along with the bid

4. Scope of Supply

Scope of supply (Bid price to include all cost components) : Supply Installation Testing and Commissioning of Goods

5. **Turnover**

Bidder Turn Over Criteria: The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. 8. **Warranty**

Warranty period of the supplied products shall be 1 years from the date of final acceptance of goods or after completion of installation, commissioning & testing of goods (if included in the scope of supply), at consignee location. OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Maintenance Service group in INDIA for attending the after sales service. Details of Service Centres near consignee destinations are to be uploaded along with the bid.

9. **Warranty**

Timely Servicing / rectification of defects during warranty period: After having been notified of the defects / service requirement during warranty period, Seller has to complete the required Service / Rectification within 7 days time limit. If the Seller fails to complete service / rectification with defined time limit, a penalty of 0.5% of Unit Price of the product shall be charged as penalty for each week of delay from the seller. - The vendor shall be an established entity with a minimum of three years of experience in manufacturing and supplying Goniometers to at least one of the following institutions: National Institutes of Technology (NITs), Indian Institutes of Technology (IITs), Research and Development (R&D) organizations, Centrally Funded Institutions (CFIs), and Centrally Funded Technical Institutions (CFTIs).

2. Equipment Specifications and Product Data Sheet:

- The quoted equipment must be the latest standard model and not an assembled unit.
- Catalogues and data sheets of the offered model must be submitted with the technical bid.
- The buyer may verify the data sheets against the offered specifications, and any unexplained mismatch or failure to submit catalogues/data sheets may lead to technical disqualification or rejection of the bid.

3. Service Network and Support:

- The vendor must have a well-trained service network in India to cater to the service requirements of the installed Goniometers.
- Details of the service network must be submitted with the technical bid.
- Dedicated /toll Free Telephone No. for Service Support: BIDDER/OEM must have Dedicated/toll Free Telephone No. for Service Support.

b) Performance Demonstration:

- The supplier must demonstrate the complete functionality of the Goniometer in the presence of the end-user or the technical committee.
- Performance acceptance shall be based on:
 - Conformity to the technical specifications, and
 - Operational stability of the system during demonstration.
- If the performance criteria are not met, the system shall be rejected without any financial liability to the buyer.
