#### **TENDER SCHEDULE**

#### PREAMBLE:

National Institute of Technology, Andhra Pradesh is the 31<sup>st</sup>NIT among the chain of NITs started by the Government of India. NIT Andhra Pradesh is established in the state of Andhra Pradesh in the academic year 2015 – 2016.

NIT Andhra Pradesh, Tadepalligudem, invites sealed tenders under **two bid** system i.e., **technical bid and financial bid** from reputed agencies/companies/authorized dealers dealing with Solid Waste Disposal at NIT Andhra Pradesh, Tadepalligudem, based on the eligibility criteria and general terms and conditions mentioned in this document.

#### **SCOPE OF WORK:**

1. The contractor has to ensure a clean atmosphere by removing all sorts of Solid Waste from the designated areas of the NIT Institute and ensure proper disposal of waste on alternative days and also certain recyclable materials like Paper, Cardboard, Packing Wood, Plastic, Scrap Metal (Steel) on monthly basis as per the terms and conditions mentioned below:

#### i) Solid Waste collection

Solid Waste includes food waste generated from mess, and other biodegradable and non-biodegradable material generated from the institute.

#### ii) Recyclable material collection

Type of recyclable material generated from the institute.

#### (a) Paper Waste:

- The Paper waste will consist of white paper, worked out sheets, envelopes with plastic labels, newspapers, magazines etc.
- The minimum rate to be paid to the Institute towards purchase of Paper waste is Rs. 8/- per Kg.

#### (b) Shredded Paper Waste:

- The shredded paper waste will consist of white/colored paper which has been shredded in the Institute shredder and is allowed for collection.
- The minimum rate to be paid to the Institute towards purchase of shredded paper waste @ Rs. 4/-per kg.

#### (c) Cardboard Waste:

- The card board waste will consist of Cardboard removed from Packaging Material.
- The minimum rate to be paid to the Institute is Rs. 7/-per kg.

#### (d) Packing Wood Waste:

- The Packing Wood waste will consist of Wood removed from Packaging Material for Equipment, Furniture, etc.
- The minimum rate to be paid to the Institute towards purchase of packing wood waste is Rs. 6/-per kg.

#### (e) Plastic Wound Waste:

- The Plastic Waste will consist of low- and high-grade plastic, clean PET Bottles etc.
- The minimum rate to be paid to the Institute towards purchase of plastic waste is Rs. 5/-per kg.

#### (f) Scrap Metal (steel) Waste:

- The scrap metal (steel) waste will consist of steel metal items left over after use by vendors on the institute.
- The minimum rate to be paid to the Institute towards purchase of scrap metal (steel) waste is Rs. 15/-per kg.

#### (g) Scrap Metal (Aluminium) Waste:

- The Scrap Metal (Aluminium) waste will consist of Aluminium metals left over after use by vendors on the institute.
- The minimum rate to be paid to the Institute towards purchase of scrap metal (Aluminium) waste is Rs.25/-per kg.
- NIT Andhra will pay to the contractor for the Solid Waste collection, and the contractor
  has to pay for the recyclable material collection. The net amount (Solid Waste amount
  minus recyclable material amount) will be paid by NIT to the contractor or vice versa on
  monthly basis.

#### **GENERAL CONDITIONS OF CONTRACT**

- Collection of waste from the designated places by engaging auto trolleys/ tractortrolleys/ dump trucks etc., suitably designed for collection.
- 2. The Contractor / Agency should arrange collection of Solid Waste in co-ordination with the timings suggested by Estate Section, NIT Andhra Pradesh.
- The following designated Solid Waste pick-up points/areas have been identified for Solid Waste pick-up which may increase or decrease as per requirement during the course of the contract.
- 4. The Solid Waste/waste collected should be transported by the contractor outside the institute.

- 5. The work will be executed/progressed continuously as per the directions of the Executive Engineer, NIT Andhra Pradesh.
- 6. The Bidder is required to make mechanism or engage sufficient manpower to collect Solid Waste alternate days.
- 7. Number of auto trolleys / tractor-trolleys / dump trucks engaged are required to be certified by the Estate Section, NIT Andhra Pradesh. If on any day or alternate day, required auto trolleys are not engaged or Solid Waste is not collected on any week, payment will be deducted proportionally from the bills claimed by contractor / agency.
- 8. The Bidder has to bring the necessary equipment, transport vehicles i.e. auto trolleys / tractor-trolleys / dump trucks etc. and personnel to carry out the above work. If the collection truck is an open truck, it is suggested to cover the truck properly while in institute to avoid odours and spilling of waste.
- 9. If any damage is caused to the NIT property directly or indirectly during execution of this work, the contractor has to make good for the damage immediately, free of cost, failing which recovery will be made from the contractor's bill to that extent.
- 10. NIT Andhra reserves the right to reject any or all the bids without assigning any reason
- 11. The Bidder is deemed to have studied the geography of the area and understood the scope of work clearly. He can visit the site during working hours and meet the officer-in-charge to familiarize himself with the area and scope of work.
- 12. The Bidder may furnish the details in the following table. Those not meeting the mandatory conditions mentioned in the table will not be eligible to participate in the tender enquiry and if they still submit the tender, the tenders of such ineligible firms/tenderers will not be considered.

#### **ELIGIBILITY CRITERIA:**

- 1. Bidder must be a proprietor/firm/company possessing valid Registration Certificate.
- 2. The Bidder must have any one of the below registration certificates.
  - a. CPWD Class-V.
  - b. Any State PWD Class- IV.
- 3. The bidder must have a valid PAN Card and the same should reflect in all financial statements.
- 4. The agency shall submit Valid Labour License registration copy.
- 5. The agency shall submit Valid EPFO, ESI, registration copy certificates.
- 6. The Average Annual turnover of FY. 2021-22, 2022-23 & 2023-24 should be at least 10 Lakhs issued by CA with UDIN Number.
- 7. The bidder should submit audited financial statements (balance sheets) for the FY 2021-22, 2022-23 & 2023-24 along with relevant income tax returns for the concerned years i.e., AY 2022-23, 2023-24, & 2024-25
- Bidder must have successfully completed the works pertaining to Solid Waste Disposal Works with the conditions and value of work/purchase orders along with satisfactory certificates defined as under during the period of 01-04-2022 to 31-03-2025.
  - One work of Solid Waste Disposal Contract costing not less than the amount equal to Rs. 10,56,000/- (Rupees Ten lakhs Fifty-Six Thousand only).

OR

 Two works of Solid Waste Disposal Annual Maintenance Contract costing not less than the amount equal to Rs. 6,60,000/- (Rupees Six Lakhs Sixty-six thousand only).

OR

- Three works of Solid Waste Disposal Contract costing not less than the amount equal to Rs. 5,28,000/- (Rupees Five Lakhs Twenty Eight Thousand only).

#### METHOD OF SUBMISSION OF BIDS:

- 4. - 7. Incomplete bids or bids not submitted in prescribed format are liable for rejection.
- 8. Institute will not be responsible for postal delay.

#### **EVALUATION PROCEDURE:**

- At the first stage, the Technical Bids shall be opened in the presence of Bidders, who
  may like to be present on 02.07.2025 at 03.30 PM. in Central Stores & Purchase
  section, Sardar Vallabhbhai Patel Administrative Vista Building of NIT Andhra
  Pradesh, Tadepalligudem.
- 2. IPC would evaluate the technical bids submitted by the Bidders.
- 3. Prior to detailed evaluation, the Institute will determine the substantial responsiveness of each bid to the tender document. A substantially responsive bid is one which conforms to all the terms and conditions of the bidding/tender document and is without any material defects and deviations. Deviations from, or objections or reservations to critical provisions such as those concerning qualification/eligibility criteria, availability of facilities and amenities as needed, availability of government/statutory approvals and clearances, ready and explicit willingness to accept and honor the terms and conditions of contract etc. will be deemed to be material deviations.
- 4. If a bid is not substantially responsive, it will be rejected by the Institute and may not subsequently be made responsive by the Bidder by correction of the non-conformity.
- 5. Only those Bidders whose technical bids have been found to be substantially responsive would be evaluated.
- 6. The Financial bids of those Bidders only shall be opened who qualified in the Technical Evaluation. The Institute will award the contract to the Successful Bidder, whose financial bid is the lowest price bid among all the quoted bids. The decision of the Director, NIT Andhra Pradesh, Tadepalligudem, is final in this regard.
- Tenders with revised/modified rates/offer after opening of the tenders shall be summarily rejected and the entire Earnest Money Deposit (EMD) submitted with the tender shall be forfeited.
- 8. The tender is not transferable under any circumstances.
- 9. Telegraphic, conditional or incomplete tenders shall not be accepted. Canvassing of any kind, director indirect shall lead to disqualification of the Bidder.
- 10. In case of a further tie, the contract will be awarded to the firm that has the highest Average Annual turnover for the last three years.
- 11. On going work will not be considered for the technical evaluation.
- 12. Joint ventures/consortiums and special purpose vehicles are not acceptable.
- 13. For similar works, works executed in India only shall be considered.

#### PAYMENT:

The **Payment** will be made every month by 10<sup>th</sup> of proceeding month after submission of the bills in duplicate in the last working day of previous month with the no. of trips on alternate days to dispose of Solid Waste and upon proof of payment made towards all applicable statutory bodies.

A copy of challan in proof of EPF and ESI deposited and any other payments thereto contractual and statutory obligation, made in respect of such engaged employees from the previous month deputed for this work, be enclosed by the Service Provider with the monthly bills. A certificate that previous month payments of the employees under the Service Provider and payment to the supplier/general order vendors has been made and cleared in all respect shall be enclosed, along with the list/details of such disbursement.

Monthly payment will be made of submission of bills, in favour of the contractor (in the name of the firm/agency, as per award of contract and agreement) after making necessary deductions (income Tax/TDS/GST surcharge, other statutory taxes, losses, penalty etc). The tax component (if applicable, as per the rules) shall be paid on submission of documentary proof.

#### **RESOLUTION OF DISPUTES:**

In the event of any dispute arising out of or in connection with this contract, whether during the subsistence of the contract or thereafter, the matter shall be referred to the Director, NIT Andhra Pradesh, Tadepalligudem, or any other officer nominated by the Director, NIT Andhra Pradesh, Tadepalligudem, for arbitration whose decision shall be final and binding on both the parties. The Agency agrees that the arbitrator could be an employee of the Institute and shall not have any objections in this regard. The proceedings before the arbitrator would be governed by the provision of the Arbitration Act 1996.

#### TERMINATION OF THE CONTRACT:

The contract may be terminated in any of the following contingencies: -

- a. On giving three months' notice by the Agency **OR**
- b. On the expiry of the contract, without any notice **OR**
- c. On giving one month notice by the Institute, at any time during the tenancy of contract, in case the services rendered by the Agency are not found satisfactory and in conformity with the terms and conditions of the contract and the standard prescribed for this services **OR**
- d. On Agency being declared insolvent by the competent Court of Law, without any notice **OR**
- e. On assigning of the contract or any part thereof or any benefit or interest therein or there under by the Agency to any third party or for sub-letting the whole or a part

of the contract to any third party, without any notice.

Provided that, during the notice period for termination of the contract, in the situation contemplated above, the Agency shall keep on discharging his duties as before till the expiry of notice period.

In case of termination of contract on the grounds mentioned at **Sr. No (c)** above OR in case the Agency decides to conclude the contract before the expiry of 12 months contract period without giving three months' notice as mentioned at **Sr. No (a)** above, the Agency shall forfeit the Performance guarantee held with the Institute and the Agency shall not have any claim/right against the Institute in satisfaction of this condition.

#### PENALTY:

For engaging, a smaller number of persons/Machinery specified in the tender penalty will be levied.

- 1. For Tractor with driver @ Rs. 2000/day
- 2. For Unskilled Worker @ Rs. 1500/day
- 3. If a bidder secures a penalty, 6 times during the contract shall be liable to be cancelled and the firm will be put in to the black list.

#### STATUTORY OBLIGATIONS

He shall be solely responsible for failure to fulfil these statutory obligations. The successful bidder shall indemnify / is deemed to have indemnified NIT Andhra against all such liabilities which are likely to arise out of the Contractor's failure to fulfil such statutory obligations. All documents, registers pertaining to this contract shall be maintained meticulously and shall be provided periodically for inspection. The salient features of the statutory regulations/acts are listed below and it is the responsibility of the selected Bidder that these regulations/acts and their amendments from time to time are strictly adhered to in totality. Even if the Bidder appointed for this contract may be exempt from any or all of the following employee-friendly legislation, it is incumbent on all Contractors to cover all their employees / workmen cover by this tender with these cover / benefits.

#### **COMMENCEMENT OF WORK:**

The Successful Bidder should start the work with effect from the date of commencement of Agreement by mutual consent. In case, it is found that the work has not been taken up from the date of commencement of Agreement, the NIT Andhra Pradesh, Tadepalligudem, at its sole discretion may cancel the work order and the Performance guarantee shall be forfeited without any further reference to the Bidder.
