4. Payment Terms and Conditions for 3-Year License Renewal:

Upon successful activation and claiming of the license in the institute's dashboard, L1 quoted amount shall be released. The Bank Guarantee shall be released only after completion of the full 3-year license tenure, subject to satisfactory performance during the entire contract period.
