CIRCULAR

Dated: 10th January 2024

With reference to the approval from the Director dated 10th January 2024, Heads of Departments are requested to permit B.Tech. students in their final semester, to take-up industrial or research internships from companies or universities or research Institutes, provided the following clauses (i) to (xiii) are satisfied.

In the following clauses, on-campus internship refers to internship facilitated through the T&P section of the Institute and off-campus internship refers to industry or research internship not facilitated through the T&P section of the institute.

- (i) For off-campus internships, a student should apriori seek an approval regarding no-objection to apply for the internship from the Head of the Department concerned.
- (ii) If a student obtains an off-campus internship from a Company, then the reputation of the Company shall be ratified by both the DAC of the student's host Department and Associate Dean (SCAIR) dealing with internships.
- (iii) This sub-clause (ii) applies in case the host organization is either a University or a Research Institute. The University providing the internship must be either a Centrally Funded Technical Institute in India or an Institute abroad (with a QS rank <=1000) or a reputed Research Institute. The reputation of the Research Institute shall be ratified by the DAC of the student's host Department and Associate Dean (SCAIR) dealing with internships.
- (iv) The student shall have a valid internship offer letter issued by the Company or University or Research Institute.
- (v) The student has to learn the Courses pertaining to the VIII semester in the Self-Study mode.
- (vi) A monthly attendance report of the student shall be submitted by the host organization through the student to the Head of the Department concerned. For off-campus internship, the attendance report shall be forwarded through the Supervisor of the student in the host organization to the Head of the Department concerned.
- (vii) The student shall submit a project report for evaluation to the project evaluation committee which includes a bonafide internship certificate issued by the host organization.
- (viii) The student needs to attend in-person in NIT Andhra Pradesh, mid and end theory exams, mid and end reviews to present the student's work to the Project Review Panel constituted by the Head of the Department concerned, whenever the institute conducts these exams and reviews. In case, a student attends an overseas internship outside India, then the student must take-up mid and end exams in person in NIT Andhra Pradesh; However, the student availing

- an overseas internship, may be permitted to write Mid Exam along with the End exam. Minor assessments may be conducted in the online mode for students availing internships.
- (ix) In case of on-Campus internships, the prescribed Internship Application and Undertaking Form for On-Campus Internships (Annexure I) shall be submitted through Associate Dean (SCAIR) dealing with T&P (Forwarding authority) to the Head of the Department concerned (Approval Authority).
- (x) In case of off-campus internships, the prescribed Internship Application and Undertaking Form for Off-Campus Internships (Annexure II) shall be forwarded by the DAC Chairman and approved by the Associate Dean (SCAIR) dealing with internships.
- (xi) Typically, the project work carried out by the student during the internship in the host organization, shall be considered for the Project Work (Part B). In case the internship work is not aligned with the Core discipline of the student then, the student may be asked by the Head of the Department concerned to additionally continue working on the discipline specific project carried out in Project Work (Part A) and, to report the continuation of the Project (Part A) work carried out by the student in the VIII semester for the Project Work (Part B). Even in this case, the student must submit an internship completion certificate along with the Project Report for the Project Work (Part B).
- (xii) In case a student discontinues the internship, the student should immediately report back to the Head of the Department concerned, along with a reason for discontinuation and proof for the same issued by the host organization.
- (xiii) The Student must not have any active R grade in any of the courses till VII Semester for undertaking any internship in VIII semester.
